



## 3-1-c Regulations

### "Crediting of educational achievements already made" (CAM)

#### A. General

Cross-entry into the eurythmy therapy training in Dornach is possible by arrangement. If the previous learning achievements can be recognised, they will be credited to the existing contents of the eurythmy therapy training in Dornach and then it will be determined how far the training period can be shortened.

In order to view and assess the learning achievements to date (number of hours, content), these must be documented in detail and in writing. This results in a competence and qualification profile which is placed in relation to the curriculum requirements of the eurythmy therapy training in Dornach and to future professional practice. In doing so, we follow the guidelines from the international curriculum of the International Trainers' Conference Basic Training and Eurythmy Therapy, as well as the guidelines of the OdA KT (Swiss Professional Organisation Complementary Therapie). This enables a uniform competence profile, a transparent structure of the partial qualifications and facilitates the equivalence examination of the basic training. The level and subject knowledge are examined individually in each case. In justified exceptional cases, conditions can be agreed according to which any significant gaps in the qualification must be made up at a later date.

#### **Eurythmy Therapy Training Dornach checks within the framework of the CAM procedure,**

- whether certificates (diplomas, passes, etc.) are available to prove that the trainee has successfully completed the required learning outcomes,
- whether and to what extent the information on the competences, objectives, contents and duration of the learning achievements can be brought into line with our course.

#### B. Procedure

##### Step 1

Proof of learning achievements is submitted to the Head of Eurythmy Therapy Training Dornach together with the application form on the basis of existing timetables, course confirmations and certificates. The number of lessons attended, topics and learning objectives must be evident from the documents and certified. Written work can be submitted as partial proof of competence for a module.

The more carefully and clearly the documents are compiled for submission, the less work we have to do and the correspondingly lower the costs.

In the CAM procedure, higher-level criteria such as the completeness, authenticity and topicality of the documents are also used for the assessment. In addition, Eurythmy Therapy Training Dornach assesses the general suitability of the applicant and the quality of previous training.

A further assessment criterion can be the movement qualities of the person applying for lateral entry; the perception and assessment of the movement abilities of the applicant represents a further criterion for the placement in the level levels of the course by the eurythmy therapy training.

If the competences cannot be determined reliably enough from the documents or if the training was completed some time ago, the eurythmy therapy training Dornach can

- obtain further documentation with the consent of the trainee,
- request the trainee to provide evidence of subject areas, hours and/or competences,
- have a clarifying discussion with the applicant.

## **Step 2**

After a review of the documents and a positive assessment, the applicant receives a confirmation of the CAM.

The certificates are issued when

- the external learning outcomes can be recognised and any missing evidence of competence has been submitted;
- the costs for the CAM procedure, for the module certificates and possibly for additional tuition and certificates of competence to be made up for have been paid.

## **Costs for the CAM**

- Flat-rate basic price/module: CHF 100.-
- Costs review according to effort/hour: CHF 80.-
